One of dad's friend may have assisted with ██████ getting a job. ██████ was supposed to tidy up the place ██████ was not allowed to use any machinery ██████ was working at the company trying to earn money during Christmas break. The child was being paid by the company. However it is unknown how much the company was paying the child to clean up. The child had only been working for the company for a couple of weeks. It is unknown if the child had to miss any school while working for the company ██████ was not forced to do things that was unsafe at the job. No further information have been obtained on ██████ parents at this time.</p>

The friends' sister and brother in law were in a bedroom along with two toddler children at the time of the incident. ██████████ sister and brother in law were the only adults in the home at the time of the incident. ██████████ sister contacted 911 for assistance. At 6:41 p.m. law enforcement was dispatched to the incident location. ██████████ tried to stop the bleeding from one of the victims, but she was unsuccessful. One victim had a wound to the head ██████████ and one to the upper arm ██████████. The adults did not know that the children had guns. Mom does have a gun but it is kept away. ██████████ and ██████████ were both pronounced deceased by Miami Dade Fire and Rescue.
