# TALLAHASSEE AREA REFUGEE TASK FORCE MEETING

#### **INTRODUCTION**

The meeting was held at the Department of Children and Families Conference Room, 201, Building 3 and Theresa Leslie, Community Liaison represented (DCF), Refugee Services (RS) Program and led the meeting. The meeting was called to order.

## PRESENTATION

The International Rescue Committee (IRC) Representative was not present to provide updates. Chase Beasley, the AmeriCorps Vista staff volunteer assigned to IRC described his recruitment of volunteer tutors for a summer tutoring program being offered to both middle and high school students in Leon County. Mr. Beasley has committed to work the next year in developing educational supports and other experiences for refugee youth. As mentioned during the last task force meeting, he has already met with teachers and administrative staff working with ESOL teachers.

Mr. Beasley provided volunteer recruitment flyers for each participant to distribute to others who may be interested. Volunteer prospects are encouraged to email Ms. Beasley to ask for additional details and seek an appointment if further interested.

Nims Middle School was awarded a Century 21 Grant to conduct summer school during the break. Those graduating elementary school and ready for middle school are eligible to participate. Refugee students and many newly arrived students will be attending academic and ESOL sessions.

Mr. Beasley explained that volunteers can commit to tutoring during the day (at summer school sessions for middle schoolers) or volunteer in the evening at Walker Ford Community Center (for high school students). He explained that each volunteer will need to get a background screening per IRC policy.

Karen Strange (from the city of Tallahassee's Adult Literacy Volunteers Program) discussed their efforts to offer evening classes for ESOL and GED prep at the Perry Library. These classes have been well attended by refugees.

Mr. Beasley also announced that two of the apartment complexes where many refugees live will making community rooms available for English classes.

## **BRIEF PROVIDER UPDATE ON NEW ARRIVALS AND EMPLOYMENT**

Ms. Leslie mentioned that IRC is on track to welcome 150 new arrivals for the coming fiscal year, October 1, 2018 to September 30, 2019. The provider has requested additional Match Grant slots.

IRC continues to focus on the recruitment of employers that offer on-the-job training, career laddering, and mentorship/internship opportunities. These outreach efforts are coordinated by Molly Woodsum, the IRC Employment Case Manager. This is an ongoing effort.

#### HUMAN TRAFFICKING :

Rebecca Zoeller, from Legal Services of North Florida (LSNF), recently joined the LSNF team and will be working with a team of attorneys that will aid victims of human trafficking in North Florida through a fellowship with Equal Justice Works Crime Victims Justice Corps. This new fellowship at LSNF will provide direct representation, outreach and education to victims of human trafficking in order to stop human trafficking throughout LSNF's 16 county service area in North Florida.

Ms. Zoeller will act as LSNF's fellow which provides critical legal help for vulnerable populations facing injustices like human trafficking, fraud/identity theft, campus sexual assault, and hate crime, and immigrant victims of crime with meritorious claims for immigration relief.
