## JACKSONVILLE AREA REFUGEE TASK FORCE MEETING

### INTRODUCTION

The meeting was held at the Jacksonville Baptist Association. LeAndra Stafford, Community Liaison represented the Department of Children and Families (DCF), Refugee Services (RS) Program facilitated the meeting. There were 40 people in attendance. Tadesse Fessehayee, Community Liaison Manager; David Draper, Procurement Manager, and Rebecca Lockenbach, Contract Manager, Refugee Services Program, attended the meeting. The meeting was called to order and participants introduced themselves and the agency they represented.

Taddese introduced David Draper who will be replacing him as Community Liaison Manager when he retires at the end of April 2018.

### GUEST PRESENTATION

A presentation was given by Tawanda Washington, Florida Department of Health in Duval County, Assistant Nursing Director, Community Health

Topic of presentation: "Why TB Treatment is Important"

- 1) TB (Tuberculosis) is a pulmonary disease that can be transmitted when an active individual in close proximity to someone for prolonged periods of time.
- 2) If an individual has been exposed to TB, they can present as Nonsymptomatic (not active) or Symptomatic (active).
- 3) The chest x-ray will show if person is symptomatic; the skin test will indicate if the person has been exposed; however, the blood test is the only way to determine if an individual is active or not.
- 4) If the individual is diagnosed as TB Nonsymptomatic, then that person is treated so they don't become sick. The treatment is a minimum of four months.
- 5) For active TB, treatment is at least six months and the treatment will leave some type of scarring on the lungs.
- 6) In Florida Statutes Chapter 392; TB control, it explains how contact investigations are completed and the requirements for active treatment. If treatment is not voluntarily completed then an individual can be made to comply with treatment by court order for hospitalization or jail.
- 7) During hospitalization (in-patient for two months or more), assistance with necessities such as utilities, food, rent, etc. will be provided.
- 8) There are different strains and mutations of TB and an individual can be affected by a different strain although they have been treated for TB in the past may need to be treated again.

- **Catholic Charities Bureau (Michelle Karolak, Director):**
  - CCB had 41 arrivals since Oct 2017
  - CCB Matching Grant 100% employment
  - Please refer Venezuelans w/ Asylum to CCB
  - ESOL has new classes at Denise Ct. Mon – Wed 5 pm – 8 pm
  - April 6<sup>th</sup> Seeking Refuge Concert at 7:30 pm, Location: Cathedral- Basilica of St. Augustine. This concert is featuring local refugees
- **Lutheran Social Services (Cristina Parcel, Director):**
  - LSS had 37 arrivals since Oct. 2017
  - LSS has 1 assurance
  - LSS has 0 scheduled for this month
- **Jacksonville Area Legal Aid:**
  - They are having issues with the I730 (family reunification): Clients are constantly asking why enough is not being done to help their families being reunified. They do not understand that it is not up to them but rather the federal government. They must apply within two years of arriving for family reunification.
  - Another concern raised is people are being stopped and asked for their documents. JALA will send out a pamphlet concerning the 4<sup>th</sup> amendment rights
  - USCIS is sending out letters to the Burmese asking them to present themselves for ID. They are rechecking IDs because a significant number of IDs were found to have been stolen. JALA is recommending that if you are not a citizen make sure you are represented by an attorney when you go to the USCIS office.
- **Early Learning Coalition:**
  - No waiting list for daycare services
  - Their office has moved to: 6500 Bowden Rd, Jacksonville, Fl. 32216
