## **PALM BEACH AREA REFUGEE TASK FORCE MEETING**

### **INTRODUCTION**

The meeting was held at the West Palm Beach City Hall. Miriam Rosario, Community Liaison represented the Department of Children and Families (DCF), Refugee Services (RS) Program. The meeting was called to order and participants introduced themselves and the agency they represented.

### **SPECIAL PRESENTATION**

A power point presentation given by Don Jarrell at United States Citizenship & Immigration Services (USCIS). Don shared that due to changing priorities, USCIS is now prioritizing asylum cases and cases are settled quickly. However, legal permanent residency applications are taking over a year to process and naturalization applications can take from 4-9 months to process. Info pass appointments are also being phased out and a pilot project is underway in Jacksonville to determine its effectiveness. All updates can be found at <https://www.uscis.gov/>

### **NEW ISSUES/ACTION TAKEN**

#### **Client Outreach Plan for 2018**

Miriam provided brief report on visually dramatic drop in arrival numbers. Notification received from resettlement affiliates in Florida of closures by the end of Sept. 30th (current fiscal year). Catholic Charities Dioceses of PB will be closing their Reception & Placement program and will continue their Match Grant Program. Discussions on how to best manage programs in this uncertain environment. Some suggestions in how to best utilize future funding and increases outreach; Employment programs being enhanced to serve returning/past clients, who have not been in the country more than 5 years. Project Transition is accepting registrations for their Adult Education classes and will be increasing their outreach by participating in various community events. RS providers were encouraged to collaborate & to meet to review their outreach plan. A meeting among RS providers was coordinated by Miriam Rosario.

#### **Planning for World Refugee Day (WRD) 2018**

Sindy De Leon, Supervisor YCI and Marcia Bahia, PB Sheriff Office discussed the WRD celebrations and the planning of forming the WRD planning committee. All the members will like to participate and increase community involvement specially with USCIS. Milli Rodriguez, Health Care District will contact Dr. Manzanero for possible partnership with Palm Beach State College.

**GENERAL UPDATES/ANNOUNCEMENTS:**

Discussion on the designation of Haiti for TPS is terminated effective at 11:59 p.m., local time, on July 22, 2019. The 60-day re-registration period runs from January 18, 2018 through March 19, 2018. Church World Services stated they will be having a free event to help the Haitian community obtain legal information and to register for TPS. They asked for a partnership and need of a free venue. Maribel de Jesús, Multicultural Outreach Librarian | 561-233-2783 | Palm Beach County Library System offered their branches and also Sandra Perez, Program Administrator from Catholic Charities. The event will be held this coming weekend.
