SWFL REFUGEE TASK FORCE MEETING MINUTES

This meeting was held at the Lee County Public Education Center, located at 2855 Colonial Blvd in Fort Myers, FL. Janet Blair, Community Liaison, represented the Florida Department of Children and Families. Twenty-eight people were in attendance and the meeting was called to order at 1:32pm.

PRESENTATIONS

- The first presentation was given by Sharon Sargent of Suncoast Technical College. With a motto of “prepare for a career in a year” this college offers a wide variety of vocational training opportunities. Classes and training are offered in a variety of locations including the cities of Sarasota, Venice and North Port. Both high school and adult education classes are offered including GED and ESOL classes. Florida residency is required for admission. This program would like to serve more refugee clients. - Our second presentation was by Lisa Murray, an attorney at the Bradenton/Sarasota office of Gulf Coast Legal Services. Lisa gave a basic overview of the GCLS programs and services including family law, immigration, a trafficking program and citizenship assistance. The Bradenton Office currently handles the following legal issues: Emergency Services Housing/Eviction/Foreclosure Issues, Domestic Violence Family Law, Elder Law/Senior Services, and Immigration. Naturalization fee waiver forms and N-648 Disability Waiver forms can be completed by GCLS staff as well as citizenship background checks and completion of paperwork. All services are offered free of charge. The link for the website is <http://www.gulfcoastlegal.org/>
- The third presentation was done by Donna Keith from the Florida Department of Health which has refugee clinics in both Sarasota and North Port. A full range of health services are provided at both locations including primary care, immunizations, dental services and a pharmacy. Currently this is a federally qualified health center with mental health services also being offered, however this status will change in a few months. No exams are being done at either location for citizenship and Bradenton now has a 3 month wait for the exam. - The final presentation was by Tom Melville from the Literacy Council of Sarasota. This program offers GED instruction, ESOL and basic education. Instruction is done in both small groups and in one-on-one tutoring. Largest demand for services is in ESOL. The program also contracts with businesses and schools to provide small classes at these locations. They utilize a program called English Forward which is a research based

system for adult ESOL learners. This program partners with Suncoast Technical College and more details can be found on their website at <http://www.sarasotaliteracy.org/>

PROGRAM INFORMATION & UPDATES

United States Citizenship & Immigration Services (USCIS):

New green cards and Employment Authorization Cards (EAD) are being rolled out later this month. There is also currently a phone scam targeting immigrants and refugees, where the caller ID shows up as the Department of Homeland Security (DHS) and individuals are asked to submit payments by phone. Please make clients aware of this scam and remind them that DHS and USCIS never take any payments by phone.

Lutheran Services Florida, CRS Program-Sarasota Office:

This program office currently has 700 active cases with 83% being Cuban. Due to the change in immigration policy with Cuba, the program is starting to see a slowdown in arrival numbers. However, they will be reaching out to previous clients to link them with educational and employment opportunities in order to increase their standard of living. In addition, this office has active volunteers engaging with clients and community groups & faith communities giving donations to new arrivals.

Lutheran Services Florida, CRS Program-Fort Myers Office:

An announcement was made on the upcoming World Refugee Day event to be held on Saturday, June 3rd at the Golden Gate Community Center in Naples. This free event will run from 10am to 2pm and have food, crafts and kids' activities for refugee families in the area. Several faith community volunteers are working with LSF staff to plan this year's event.

REFUGEE SERVICES UPDATE

Janet reviewed the new meeting schedule for SWFL. Due to the geographic span, task force meetings will now be held in three different locations each year. Two meetings will be in Sarasota, two in Fort Myers and two in Naples. All in attendance agreed that this format is working much better. The next meeting in Sarasota will be on October 25th and will be held here at the same location.

Janet also gave a brief overview of National Welcoming Week and there was some discussion about holding an event in Sarasota this year. A sign-up sheet was passed around for those interested in forming a planning committee.
