#### JACKSONVILLE AREA REFUGEE TASK FORCE MEETING

#### INTRODUCTION

The meeting was held via video remote meeting. LeAndra Stafford, Community Liaison, represented the Department of Children and Families (DCF), Refugee Services (RS) Program and facilitated the meeting. There were 31 people in attendance on Microsoft Teams virtual meeting. Guests included: David Draper, Community Liaison Manager, as well as several DCF staff was also in attendance. The meeting was called to order and participants identified themselves by agency in the chat box.

### **GUEST PRESENTATION**

- 1. Selena Webster-Bass, Founder/ CEO, Voices Institute LLC. *Healing the Wounds of Refugee Trauma* 
  - Trauma: the emotional response from an event, series of events, or circumstances that are interpreted as harmful or life threatening and have the potential to result in lasting negative effects on one's physical, mental, social emotional or spiritual well-being
  - Refugee Trauma: While in their country of origin, refugee families and their children may have experienced traumatic events or hardships including: Violence, War, Lack of food, water, and shelter, Physical injuries, Torture, Forced labor, Lack of medical care, Loss of loved ones, and/or Disruption in or lack of access to schooling
  - Core Stressors for Refugees: Traumatic Stressors, Resettlement Stressors, Acculturation Stressors, and Isolation Stressors
  - Recognizing and healing wounds of racial trauma: Affirmation and acknowledgement; Making space for race; Racial storytelling; Validation; Process of naming; Counteract devaluation; and Rechanneling the rage
  - Offer social, emotional, and environmental support
  - L.E.A.R.N Model
    - a) L-Listen with empathy and understanding to the client's perceptions of the problem
    - b) E Explain your perceptions of the client's problem
    - c) A Acknowledge and discuss the differences and similarities of perceptions of the client and the provider
    - d) R Recommend resources
    - e) N Negotiate agreement, treatment, care plan
  - Bridging Faith Communities and Behavioral health
    - a) Collaborate: Partner with culturally responsive behavioral health providers for referrals and in promoting mental health and wellbeing
    - b) Cope: Offer faith, hope, and cultivate resilience by assisting in creating alternative narratives
    - c) Connect: Provider prayer, sacred texts, and social supports to those struggling with mental health challenges and trauma

- d) Commune: Provide concrete supports to reduce gaps in meeting basic needs (food, shelter, clothing, masks) and transformational supports to assist in physical personal, financial, and professional transformation
- e) Avoid demonizing those struggling with trauma and viewing as mental health challenges as "personal weakness"
- 2. Laura Goodwin, Case Manager, FSCJ Workforce Recovery Training Program *FSCJ Fast Track Construction Program* 
  - Hurricane Irma 2017 caused over 85 million is damages to the city of Jacksonville, due to the is event funding was made available to prepare for the next disaster.
  - FDOE created Rebuild Florida Workforce Recovery Training Program
  - Trains Floridians in the construction trades necessary to support disaster recovery efforts <a href="www.RebuildFlorida.gov">www.RebuildFlorida.gov</a>
  - FSCJ offers 3 classes for free to students who qualify for the Fast-Track Construction Program:
    - a) Intro to Basic Construction Skills
    - b) OSHA 30
    - c) HAZWOPER 40
  - For qualified individuals the grant program includes the cost of workforce instruction, books, certifications toolbelts, and materials
  - To Qualify: Must be 18 years old or older and must be authorized to work in the U.S.
  - How does it benefit refugees?
    - a) Free to those who qualify
    - b) Equips them to be in the workforce
    - c) Places them in the workforce

## REFUGEE SERVICES CONTRACTED PROVIDERS UPDATE

- Lutheran Social Services (Laura Cook, Refugee Services Program Manager):
  - **CRS Summary** 
    - Lutheran Social Services (LSS) continues to operate. They are now open to the public and serving everyone
  - Employment: LSS made 17 placement and had 3 career laddering in the last month.
  - Youth Program is currently serving 12 clients and have started after school tutoring
  - Mentoring Program have 20 mentees
  - o R&P received 78 arrivals so far this for FFY 2021-22
- Catholic Charities Bureau (Anna Lindler, Associate Director):
  - o R&P has received 137 refugees so far this for FFY 2021-22
  - Match Grant: 132 individuals will be enrolled in the program during this quarter

  - ❖ Attendance in refugee specific classes:132
  - ❖ For the upper-level classes (vouchers to FSCJ), they had 49 voucher referrals
