PALM BEACH AREA REFUGEE TASK FORCE MEETING

INTRODUCTION

The meeting was held via Teams Meeting, Miriam Rosario (MR), Southeast Community Liaison represented the DCF, Refugee Services (RS) Program. Miriam thanked all for their participation. The meeting was called to order and participants were asked to sign in the chat to introduce themselves, services, and the agency they represented. Miriam reminded all the Refugee Task Force meetings comply with no political statements.

SPECIAL PRESENTATION

The special presentation on Early Head Start and Child Care Community Partnership was presented by Raquel Leonard, Early Head Start Family Advocate, Early Learning Coalition of Palm Beach County, Inc. Early Head Start 6 weeks to 3 years, Head Start 3 years to 4 years old, Migrant or Seasonal Head Start 6 weeks to 4 y/o. On School readiness 6 weeks to 13 y/o, Low income families working or going to school at least 20 hrs/week. Always recruiting and serving families with: Children ages 6 weeks to 3 Yrs. Old, Families who live in the following areas: West Palm Beach, Riviera Beach, Lake Worth, Delray Beach, Belle Glade and Pahokee. Families with income below the 100% of Federal Poverty Level. Automatically Eligible Families: Recipients of Public Assistance (SSI/TANF), Experiencing Homelessness, Children in Foster Care and Recipients of Public Assistance (SSI/TANF). Eligibility Priority Children who have a special need, disability concern, or a diagnosed disability (IFSP) and Teen parents. Many additional services at no cost such as Comprehensive Services, Engaging Activities, Full Day, year-round services, Family and Community Services, Parent Committee and Policy Council Opportunities, Community Resources, Inclusive Services and settings for Children with Disabilities, Mental Health Services, Dental Services, Nutritious Foods and School Readiness, Formula, Wipes, diapers and Healthy meals. NEW ISSUES/ACTION TAKEN

Sindy De Leon, Programs Employment Supervisor, Youth Co-OP, Inc. (YCI) (CRS). Sindy did the presentation covering all data for the Palm Beach County Survey Local Job Market Survey and discussed and answered all members questions. The copy of the Power Point presentation was also distributed. Florida total arrivals for FFY20 are 5,409. Palm Beach County had served 495 arrivals for 2020. The countries of origin of clients most served are Cuba (131), Haiti (295), Colombia (33), Venezuela (9), El Salvador (7) and other (20). For the past year YCI built great relationship with staffing companies and private employers. These companies support our clients by contracting our clients even if they don't speak English very well or have transportation. These employers have demonstrated consideration for our clients by trying to offer them positions near their home. Fastest PBC growing occupations are in the nursing area. YCI top employers are USCRI and Holiday Inn Hotel, average salary \$15.86 and \$12.86 respectively. During the year 2020 YCI Employment Program placed 478 clients, averaging a salary of \$10.90 per hour. Popular industry placement is in services specially assemblers and housekeeping services. Patrice Schroeder, MA, Community Relations Specialist, **211 of PBC**. Patrice provided updates on the 211. Pat indicated that 211 HelpLine Celebrating 50 Years! Invited all to the Inter-Agency Network PBC (IAN) first Tuesday of each month 9 am via zoom. The group participation in one of Palm Beach County's oldest "community-wide" networking groups. Pat provided information on "Help Me Grow (HMG)" was launched April of 2015 and is part of a national program that is designed to identify children at-risk for developmental, behavioral, or social challenges. This program is designed to support questions and concerns of families, while providing access to resources and supports. HMG connects families with free or low-cost community programs for health and developmental services. Parents and caregivers of young children (0 – 8 years) who live in Palm Beach, Martin, Okeechobee, St. Lucie or Indian River Counties are eligible to participate in the Help Me Grow program. There is no charge to participate in the 211 Help Me Grow program. The Center for Disease Control has a FREE app to track your child's milestones in English and Spanish! Free Development Screening for Children 0-5. To help a child you know obtain Help Me Grow's resources, just call 2-1-1 and tell the specialist you are interested in the program. We will ask you a series of questions to help understand the needs of your family to find you the best-matched services to support your child's health and well-being. All your answers remain confidential.

Pat also informed on the seniors over 60 Sunshine resources. Also 211's Elder Crisis Outreach program helps connect vulnerable seniors to critical services and their Sunshine daily calls to seniors is now expanding to give a daily call to caregivers of all ages. 211's MYFLVET program provides peer to peer support to veterans and also helps the veteran and their families find resources and services. ACHA highlighting current guidance related COVID-19 testing for the elderly or individuals with a serious underlying medical condition. COVID-19 testing should be considered in individuals 65 or older or individuals with a severe underlying medical condition who have new onset lower respiratory track disease or pneumonia, either the inpatient or outpatient setting. Florida continues to have the highest percentage of vaccines administered to seniors 65 and older, with vaccinations in that age bracket accounting for nearly 65% of total vaccinations in the state. Those clients are served and help locate new jobs special during approved beyond the 180 days. MG clients are also referred to Vocational courses, ESOL classes, Health, Legal services, and many needed community resources.

Cristina Veltri, Coordinator, Project Transition, updated on the spring and fall sessions. Students are participating by choice Classes are both remote learning and in classroom. Depending on their need student can switch from evening to day classes. PR/BC has incentive new program where student can borrow a lap to enroll in classes and can keep if they re-register for next semester. Virtual classes are most popular; however, the challenges are the computer skills needed. Students are eager to learn English languages and basics computer skills. Claudia Arce, ESS/DCF reported on ACCESS maximum allotments increases to 15%. SSA administration is providing fewer appointments.
