#### SWFL REFUGEE TASK FORCE MEETING MINUTES

This meeting was held via Microsoft Teams due to the pandemic. Janet Blair and David Draper represented Refugee Services, Dept. of Children & Families (DCF). There were 43 in attendance and the meeting began at 1:03pm.

#### **Presentations**

The first presentation was from Lutheran Services, Florida and focused on the community's generosity during holiday drives and events for refugee families in SWFL.

The second presentation was from Andrea Lypka with Integrated Learning/Learning Empowered. A variety of adult education classes are offered online by this Largo based program and are available free of charge to refugee clients living in SWFL. ## **Lutheran Services Florida (LSF) Update**

All offices continue to be open and working with clients. There has been a decline in new clients arriving in SWFL this past quarter, but employment is strong for those who are arriving with the ability to immediately work. The relationship with the Social Security Administration has improved and clients are being seen for new cards in all counties.

## **USCIS Update**

The Fort Myers Field Office has caught up on 75% of the backlog in cases. Naturalization ceremonies are being held on most days of the week.
