  - o Funding dependent on utilization of index

  - o Data Transparency: Develop a pilot Master Client Index
  - O Data Transparency: Develop a workgroup to establish a statewide core set of metrics that will provide a comprehensive, standardized, and transparent approach to assessing and evaluating quality of care and health outcomes (Berner)
  - Access to Care: In partnership with AHCA, conduct an exploratory study to assess the potential impact of adjusting the Medicaid income eligibility criteria for young adults ages 18-21 coverage gap whose parents are not insured (Evans)
  - o Access to Care: Implement a 3-year pilot in which one agency level entity manages all public, behavioral health funding in a geographic area (Reynolds)
  - Access to Care: Create a coordinated community behavioral health approach for public school students utilizing a single organization and amend section 1006.05, F.S. (Berner)
