SUBJECT: Diversion Programs - Subsidized Child Care Services

This memorandum outlines the purpose and referral guidelines for at risk families needing access to child care who are served through Diversion Programs operated by the Department of Children and Families (DCF) and its contracted Community-Based Care (CBC) agencies. The Diversion Programs are for children who are currently served by the Family Safety Program Office. Child protective investigators refer families to the Diversion Programs for service delivery and follow-up when it is determined that abuse/neglect is not present but services are necessary to provide protection for the child(ren). To ensure the provision of child care services to this priority eligibility group, Early Learning Coalitions (ELC) are to accept and act upon these child care service referrals in accordance with section 411.01(6)(b), Florida Statutes (F.S.).

The Department of Children and Families, Community-Based Care agencies, the Agency for Workforce Innovation, and ELCs coordinate to process referrals from and serve families in Diversion Programs as follows:

- Department of Children and Families Protective Investigations or Diversion Program staff:
 - Complete the initial child care referral for eligible families in need of child care,
 - Request child care in 60 day increments but do not exceed six (6) months in total,
 - Mark primary purpose of care as "Protection" and mark any secondary purpose,
 - Indicate "Diversion Program" under type of referral, and
 - Indicate the minimum number of hours each child needs care.
- Early Learning Coalition staff:
 - Serve the referred child(ren) under category BG1 11,
 - Email information to the designated points of contact when updates to the referral information is needed, and
 - Notify the referring agency when a parent has not contacted the ELC within ten (10) days of referral issuance (In such cases, the DCF/CBC must issue a new referral).
