**SUBJECT:** Tuition and Fee Exemption for Former Foster Youth and Positive Pathways Program (Positive Pathways)

---

**PURPOSE:** The purpose of this memorandum is to provide information regarding updates to the Department of Children and Families (DCF) Tuition and Fee Exemption for former foster youth and collaboration with Florida's Board of Governors, State University System, College System, and Department of Education through Positive Pathways.

**BACKGROUND:** For over two decades Florida public postsecondary education institutions have provided eligible former foster students tuition and fee exemptions. In order to have the tuition and fees waived, students must obtain a signed DCF form letter, CF-FSP 5220, validating eligibility from a Community-Based Care Lead Agency Representative. Effective July 1, 2019, s. [1009.25](#) Florida Statutes (F.S.), was amended to include eligible former foster care students that reach 18 years of age while in the custody of a relative or nonrelative participating in the Guardianship Assistance Program. Currently, the following students are eligible for the exemption until the young person reaches the age of 28 years of age:

- He or she is or was at the time he or she reached age 18 in the custody of DCF; or,
- He or she was adopted from DCF after May 5, 1997; or,
- He or she is or was at the time of reaching age 18 in the custody of a relative under s. [39.5085](#), F.S.; or,
- He or she is or was at the time of reaching age 18 in the custody of a non-relative under s. [39.5085](#), F.S.; or,
- He or she is or was at the time of reaching age 18 in the custody of a guardian under s. [39.6225](#), F.S.; or,
- He or she was placed in a guardianship by the court after spending at least 6 months in the custody of the department after reaching 16 years of age.

In May of 2017, Positive Pathways was established to coordinate, develop, and maintain a network of postsecondary education liaisons to improve outcomes and career transitions for former foster youth eligible for the DCF Tuition and Fee Exemption. This work is a continuation of support, networking, and collective impact that began in 2013 with the establishment of Florida Reach and in response to s. [409.1452](#), F.S., relevant to the required collaboration with postsecondary educational institutions.
