This FSFN reference guide is to provide guidance to Child Welfare Community-Based Care Lead Agencies (CBCs) on which Reporting Category should be used for each Service Type created in FSFN. The Office of Revenue Management in the CFO Group at DCF maintains the table in FSFN that associates the Other Cost Accumulator (OCA) to each Reporting Category. CBCs are required to report payment information from FSFN to DCF by OCA each month.

Below is a table, in alphabetical order, of the “current” Reporting Categories in FSFN seen today and the “new” Reporting Categories scheduled to be added to FSFN during the week of December 15th. This table provides a quick “at-a-glance” view of the Reporting Categories along with the Eligibility, OCA, and OCA Title attached to each one. In addition, another table below provides of the Reporting Category and the National Youth in Transition Database (NYTD) Reporting Group combination to be used when a Service Type is created and/or updated. Below the tables, descriptions are provided of the allowable supports and services to be captured within each Reporting Category.

Note: CBC questions regarding the information contained in this guide should first be addressed through the DCF Contract Manager.

CURRENT:

- **ADOPTION**

Direct payments to the adoptive parents as a result of an adoption assistance agreement (as defined in Section 475(a)(3) of the Social Security Act) entered into by a State with parents who adopt a child with special needs.

The State –

- Shall make payments of nonrecurring adoption expenses incurred by or on behalf of such parents in connection with the adoption of such child, directly through the State agency or through another public or nonprofit private agency, in amounts determined under Section 475(a)(3) of the Social Security Act, and
- In any case where the child meets the requirements of Section 475(a)(2) of the Social Security Act, may make adoption assistance payments to such parents, directly through the State agency or through another public or nonprofit private agency, in amounts so determined. [Section 475(a)(1)(B) of the Social Security Act]

Note: The nonrecurring adoption expenses shall not exceed \$1,000 per adoptive child for that particular adoptive placement.

Direct payments to young adults, ages 18 up to 23, who after 16 were adopted from foster care or placed with a court-approved dependency guardian for costs associated with room and board and educationally related expenses, such as tutoring, summer school, and/or supplies.

PLEASE NOTE: The Independent Living Program’s Road to Independence (RTI) will no longer become available to young adults formerly in foster care, effective January 1, 2014. A young adult currently participating in RTI will continue his or her participation until reaching the age of 23 or otherwise becoming ineligible, due to the young adult not meeting the ongoing requirements of RTI set forth prior to January 1, 2014. After January 1, 2014, there is no reinstatement option for any currently enrolled young adult in the former RTI, due to a young adult becoming ineligible.

A young adult currently participating in RTI will continue his or her participation until reaching the age of 23 or otherwise becoming ineligible, due to the young adult not meeting the requirements of RTI set forth prior to January 1, 2014. After January 1, 2014, there is no reinstatement option for any currently enrolled young adult in the former RTI, due to a young adult becoming ineligible.

PLEASE NOTE: The Transitional Support Services, provided through the Independent Living Program, will longer become available to young adults formerly in foster care, effective January 1, 2014. A young adult participating in this program on or before December 31, 2013, will continue receiving Transitional Support Services until March 31, 2014, unless he or she becomes ineligible to continue in the program prior to that date.

Direct payments to a foster family home for children, licensed by the State in which it is situated or has been approved, by the agency of such State having responsibility for licensing homes of this type, as meeting the standards established for such licensing. [42 U.S.C. § 672(c)] These direct “foster care maintenance payments” are to cover the cost of (and the cost of providing) food, clothing, shelter, daily supervision, school supplies, a child’s personal incidentals, liability insurance with respect to a child, reasonable travel to the child’s home for visitation, and reasonable travel for the child to remain in the school in which the child is enrolled at the time of placement. [42 U.S.C. § 675(4)(A)]

Note: If the child placed in a foster family home is the parent of a son or daughter who is in the same home and payments described in Section 475(4)(A) of the Social Security Act are being made under this part with respect to such child, the foster care maintenance payments shall also include such amounts as may be necessary to cover the cost of the items described in Section 475(4)(A) of the Social Security Act, with respect to such son or daughter. [42 U.S.C. § 675(4)(A)]

A “child’s personal incidentals” are typically purchased for the child on an occasional, as-needed basis and may include a variety of items. Examples of some “personal incidentals” include:

- **GROUP HOME**

Direct payments to a private or public child-care institution that accommodates no more than twenty-five (25) children and is licensed by the State in which it is situated or has been approved by the agency of such State having responsibility for licensing homes of this type as meeting the standards established for such licensing.... [42 U.S.C. § 672(c)] These direct “foster care maintenance payments” are to cover the cost of (and the cost of providing) food, clothing, shelter, daily supervision, school supplies, a child’s personal incidentals, liability insurance with

respect to a child, reasonable travel to the child’s home for visitation, and reasonable travel for the child to remain in the school in which the child is enrolled at the time of placement. [42 U.S.C. § 675(4)(A)]

Note: If the child placed in a child-care institution is the parent of a son or daughter who is in the same home and payments described in Section 475(4)(A) of the Social Security Act are being made under this part with respect to such child, the foster care maintenance payments shall also include such amounts as may be necessary to cover the cost of the items described in Section 475(4)(A) of the Social Security Act, with respect to such son or daughter. [42 U.S.C. § 675(4)(A)]

For the purposes of this cost pool and for AFCARS reporting purposes, “Group Homes” are described as child-care institutions, which are substitute care settings that house twelve (12) or fewer children. [Administration for Children and Families, Child Welfare Policy Manual 1.2B.7-6]

For the purposes of this cost pool and for AFCARS reporting purposes, “Institutions” are described as child-care institutions, which are substitute care settings that provide care for more than twelve (12) children. [Administration for Children and Families, Child Welfare Policy Manual 1.2B.7-6]

A “child’s personal incidentals” are typically purchased for the child on an occasional, as-needed basis and may include a variety of items. Examples of some “personal incidentals” include:

- Cosmetics;
- Fees related to activities, such as Boy/Girl Scouts;
- Funeral expenses;
- Graduation fees;
- Infant and toddler supplies, including high chairs and diapers;

This 12-month period follows each state fiscal year. The amount of \$6,250 may not exceed the actual cost of attendance for the postsecondary educational institution in which the young adult is enrolled. A cost of attendance assessment is required. ETV funds are to be paid directly to the young adult unless the young adult requests otherwise. These funds are to help eligible students who are former foster care children receive the educational and vocational training needed to achieve independence.

The amount of the financial assistance for a young adult who does not remain in foster care and is attending a postsecondary school, as provided in Section 1009.533, Florida Statutes, is \$1,256.

A young adult is eligible to receive financial assistance during the months when enrolled in a postsecondary educational institution.

The amount of the financial assistance may be disregarded for purposes of determining the eligibility for, or the amount of, any other federal or federally support assistance.

The Chafee Education & Training Voucher (ETV) Program is for eligible 18, 19, 20, 21, and 22 year old young adults, formerly in foster care, who are attending an institution of higher education, on a PART-TIME or FULL-TIME basis, as provided by federal law (Higher Education Act of 1965, Public Law, Sections 101 and 102). Note: The institution of higher education determines the number of hours required to be determined a part-time or full-time student for the purposes of the ETV program. Section 409.1451(2)(a)4., Florida Statutes, deems nine (9) credit hours “full-time” for the purposes of determining eligibility for the PESS Program ONLY.

A young adult participating on the date he or she attains 21 years of age remains eligible to continue receiving the voucher until 23 years of age, as long as he or she is enrolled in a postsecondary education or training program and is making satisfactory progress toward completion of that program. Federal law (Public Law 107-133, Title II, Section 201) requires initial participation in the program prior to the young adult's 21st birthday. PLEASE NOTE: Historically, the fund split for an ETV OCA was 80% Federal (ETV) and 20% State Match. To maximize efficiencies for the Community-Based Care (CBC) Lead Agencies and to ensure the federal maximum amount per young adult in a 12-month period is not exceeded, the Department is adjusting the fund split to **20% Federal (ETV) and 80% State Match**. This change will enable CBC Lead Agencies to continue with one OCA during the entire 12-month period without having to change the OCA once the young adult has exceeded the maximum federal earnings.

The supplemental board rate paid to foster parents is effective January 1, 2014. Pursuant to Section 409.145(4)(b), Florida Statutes, Community-Based Care Lead Agencies must pay a supplemental room and board payment to foster care parents for providing independent life skills and normalcy supports to children who are 13 through 17 years of age placed in their care. The supplemental payment shall be paid monthly to the foster care parents on a per-child basis in addition to the current monthly room and board rate payment. The supplemental monthly

Payments made directly to the Community-Based Care Lead Agency are to secure housing and utilities, with the balance being paid directly to the young adult until such time the lead agency and the young adult determine that the young adult can successfully manage the full amount of the assistance.

In addition, services are provided to In-Home non-dependency children, where verified findings of maltreatment have occurred in the past, in an effort to prevent any maltreatment from occurring again.

- Legal Services
- Respite
- Temporary Housing
- Transportation

In-Home non-dependency clients are those families and households in which the child is not under the State's and/or court ordered supervision.

- **ACADEMIC SUPPORT**
 - ✧ Report whether a youth received academic services designed to help a youth complete high school or obtain a General Equivalency Degree (GED).

- **POST-SECONDARY EDUCATIONAL SUPPORT**
 - ✧ Report whether the youth received support designed to help the youth enter or complete college. For example, test preparation, college counseling, assistance with applying for college and securing financial aid and tutoring while in college.

- **CAREER PREPARATION**
 - ✧ Report whether the youth received services that develop a youth's ability to find, apply for, and retain appropriate employment.

- **EMPLOYMENT PROGRAMS OR VOCATIONAL TRAINING**

 - ✧ Report whether a youth receives education on maintaining healthy families, including parenting and childcare skills, spousal communication, family violence prevention and responsible fatherhood.

- **MENTORING**
 - ✧ Report whether a youth receives mentoring, which is defined as programs or services in which a youth meets regularly with a screened and trained adult on a one-on-one basis. Please note: This is only to collect data on mentoring as a service that is provided by the State agency.

- **SUPERVISED INDEPENDENT LIVING**
