Necessary When Creating A Service Type

Setting up the Service Type is the "first line of defense" in ensuring the FSFN processed payments are claimed by fund source accurately, such as:

- ▶ Setting up the Service Types for Placements and Services, <u>with special attention to</u>:
 - How to set up if the cost is allowable as a Title IV-E Foster Care Maintenance Payment and the fund source should be determined based on the child or young adult's Title IV-E Eligibility.
- Reporting Category Descriptions, which:
 - Describe what types of costs <u>can be</u> claimed for the Reporting Category, i.e., allowable costs;
 - Should the Service Type be directed to the child/young adult's Title IV-E Eligibility Record based on the Reporting Category chosen;
 - ► Other Cost Accumulators (OCA) associated with the Reporting Category; and
 - Program Eligibility {for some of the Reporting Categories}.

2.2 - Required Standardized FSFN Service Types

2.2.1 - Levels of Licensure {Effective April 12, 2019}

All new Service Types created after April 12, 2019, <u>must include the licensure level</u> at the beginning of the 'Placement' Service Type's Short, Medium, and Long Descriptions.

The below Service Types shall be created within the Maintain Services page for Foster Care Maintenance Payments of children placed in a DCF licensed foster home.

<u>Note:</u> Fields marked with (*) denote optional method to setting up Service Type. All other fields are required as indicated.



Level I Licensed Foster Home – 'Placement' Service Type utilized for children placed in a foster home with a Level I, child-specific license.

SLA Non Paid Temporary Absence – This is a non-paid 'Placement' Service Type used when an EFC young adult has a temporary absence from his/her approved supervised living arrangement whether it be planned or unplanned. When a young adult is in this type of placement, all placement and transition type services shall be provided by and/or coordinated by the supervising agency. Examples of when this placement should be used include, but are not limited to, the youth turning 18 years of age during a runaway episode, youth turning 18 years of age placed in an involuntary commitment program, young adults who are detained/arrested/incarcerated, or other extenuating circumstances that would cause a young adult to temporarily leave his/her approved supervised living arrangement.

Remember: Please set this 'Placement' Service Type up as non- paid. <u>When doing this, the 'Reporting</u> Category' data field will be grayed out and disabled.

By doing this, when a child is placed with a licensed CCA, Placement Staff within the CBC can record the placement to the appropriate 'Placement' Service Type, preventing the need for correction entries later.

In situations where the OCA Begin and End Dates don't seem right, such as the year being 1899 or the End Date is prior to the Begin Date, this usually happens when the Service Type's Eligibility data field is set up as 'Applicable'. When this is the case, here is the first {and usually the last} thing to check:

- ► The Child's Eligibility pages Yes, "pages"...
 - For the foster care maintenance payments, there are most likely two (2) open Title IV-E Eligibility pages; and
