#### 3. Review of Statutory Duties for Subcommittee

Chair Reeve provided clarification on the statutory direction for this subcommittee. As directed by the legislature, this subcommittee will review data collection, reporting mechanisms and other data sources related to behavioral health across all available datasets, make recommendations for development of statewide behavioral health data repository in order to address the quality and effectiveness of current mental health and substance use disorder services, delivery systems, identify gaps and, make recommendations.

#### 4. Statewide Data Repository Update

Behind the scenes work has been completed. We must determine the data governance process. We need to clearly define things and know how access will be obtained. There also must be a public process established. We need to figure out what the capacities are at the universities to take on this kind of project, from both a technology security level and a scientific standpoint. We need to do a deeper dive into ongoing costs it would take to work with some of these larger data management companies and whether that would

be sustainable long term. Confidentiality will also be a huge part of this rollout.
