### 1. Approval of the June 27, 2023, Meeting Minutes

### 2. Gap Analysis Report Out

Subcommittee Members

Previously selected subcommittee members and subject matter experts provided a gap  
analysis by region:

- Lynne Daw presented a gap analysis for the Northwest region. The Agency for  
Persons with Disabilities (APD) initiated a pilot workgroup specifically focused on  
process improvements as it relates to involuntary Baker Acts and the discharge  
process. The workgroup identified a total of 24 gaps, which fall into 3 primary  
categories of focus:
  1. Collaboration and Community Resources
  2. Discharge Planning
  3. Training Needs
- There was no report out for the Northeast region.
- There was no report out for Suncoast region.

- Heather Allman presented on the Southern and Southeast regions. Ms. Allman identified that the southeast region had no existing clubhouse models in Indian River, Okeechobee, and St. Lucie County. Additionally, FACT has a waitlist.
- Secretary Harris asked that all gap analysis leads send written reports to Aaron Platt.

### **3. CCBH Workgroup Report Out**

Jennifer Johnson, Senior Director of Public Policy, Florida Behavioral Health Association

- Jennifer Johnson gave the CCBH committee report on behalf of Melanie Brown Woofter. The group is considering a framework that fits within the current system, especially cost.
- At the request of Secretary Harris, the group is considering if there is a tenant of CCBH that speaks to connectivity to the hospital system.
- Mary Mayhew commented that having consistent access to real-time data will be key.
- Charlene Zein shared that health plans would also benefit from access to timely data.
- Chair Reeve shared that the data analysis subcommittee is looking into legal and statutory language around data sharing.

### **4. The “No Wrong Door” Model: Mobile Response Teams and Central Receiving Facilities**

Amanda Regis, Statewide Baker Act and Marchman Act Coordinator

- Amanda Regis gave a high-level overview of services that embody the “No Wrong Door” model, including mobile response teams and central receiving facilities.
