### Reimagining the Behavioral Health Care Workforce:

Nicoleta Zenn provided an overview of the University of South Florida's center for behavioral healthcare educational studies programs and the Bachelor of Science in Behavioral Health Care degree tract. Review USF's three concentrations, Applied Behavior Analysis, Children's Behavioral Healthcare and, Behavioral Healthcare Across the Life Span.

Discussion surrounding partnering with other colleges and universities, high schools and possibly certifications programs, workforce turnover, possibility of a state designated organization that regularly examines behavioral health care gaps, capacity, accessibility and need.

# Interim Report Discussion – Preliminary Recommendations:

Therapeutic Group Care Recommendation

Commissioner Rein reviewed the Therapeutic Group Care draft recommendation but stressed therapeutic group care in just one piece of the statewide therapeutic residential treatment options, namely therapeutic foster care and the statewide inpatient psychiatric program. Discussion surrounding the different levels of oversight and funding and, reimbursement rates.

### Schools and Community Partners MOU Recommendation

Maria Bledsoe (Subject matter expert) reviewed the draft recommendation for improving care coordination between school districts and community behavioral health care providers. This draft recommendation promotes a memorandum of understanding between school districts and their local managing entity to address children and youth behavioral health concerns. The agreement should clearly define the scope of work, performance measures, referrals, and care coordination.

Discussion regarding the possibility of including recommendation for transportation of individuals subject to involuntary examinations and, improving public education and awareness of the behavioral health care system and doors to access.

#### **Public Comments:**

Shelley Katz (Lutheran Services Florida): A county (Gilchrist) within the LSF catchment area disbanded its school mental health services program in favor of school safety. Was that a district decision or Department of Education decision? Andrew Weatherill with the DOE will follow-up.
