### Facilities & Infrastructure

- NWRDC's facilities are staffed and available 24x7x365. We provide environmentally controlled floor space at both our Tallahassee and Atlanta locations, including designated Criminal Justice Information Systems (CJIS) floorspace. In 2018, NWRDC's Tallahassee facility weathered Category 5 Hurricane Michael with no service interruption.
- Our Cloud Infrastructure Services (CIS) solution provides a fully hosted virtual data center in a resource on-demand model. CIS components are also available at multiple physical locations, allowing customers to perform disaster recovery exercises and conduct workload sharing across sites.

## Networking

 NWRDC's 26-mile Tallahassee Fiber Loop (TFL) serves as the onramp to the Florida LambdaRail and Internet 2 for FSU, FAMU, and several other organizations. Firewall services and commodity internet services are also available.





## Storage Services

 Storage as a Service (STaaS) provides high performance, fiber channel connected, ondemand block level storage that can be used within a customer's or NWRDC's physical or virtual environments. This fully-encrypted platform is available at both Tallahassee and Atlanta sites, making it an ideal solution for disaster recovery needs. Its scalability ensures our customers pay only for the storage allocated to them at any point in time, providing outstanding cost efficiencies over traditional models.

## Backup and Recovery

- NWRDC's cloud-based Backup as a Service (BaaS), is available in a flexible, consumption-based model and provides customers with advanced control over their backup and recovery process. This on-demand solution eliminates the need to pay for extra storage customers may have sitting idle and is a key element in many of their disaster recovery plans.
- NWRDC can manage backups, or the customer can self-manage. NWRDC managed backups are tested every quarter to ensure recoverability.





## Managed Services

- Managed services are offered for both physical and virtual servers. Our staff provide server installations, builds, configurations, patching, maintenance, server hardware/OS troubleshooting, as well as a robust monitoring toolset.
- NWRDC works to ensure our staff are up-to-date on the latest technologies with an annual 30-hour professional development requirement and a certification bonus reward program. Staff completed a total of 2,740 hours of professional development in FY 22-23.

### Mainframe as a Service

- In 2020, NWRDC established a State of Florida cloud solution for mainframe services, available through a capacity-on-demand model. This z/15 platform, maintained by business partner Ensono, is available in both Tallahassee and Atlanta sites.
- MFaaS generated an initial savings of \$700,000 for the State of Florida in FY 20-21. Through recent software optimization efforts, NWRDC was able to secure an additional \$6.7M in mainframe cost savings for the state through 2025.


### The NWRDC Advantage
