Review and Approval of June 12, 2024 Meeting Minutes

2025 Subcommittee Structure – Chair/Co-Chair/SME Lead Duties

Commission Chair Jay Reeve outlined the subcommittee structure, how to join the subcommittee, the duties and responsibilities of the co-chair and the subject matter experts from the related agencies. Additionally, Chair Reeve briefly discussed the parameters of Florida's Sunshine Law and its applicability to the members of the Commission and subcommittees.

Commission Legislative Update

The bill incorporates several of the Commission's recommendations contained in the January 1, 2025 Interim Commission Report submitted to the Legislature and Governor's Office. Subject Matter Expert Heather Flynn, PhD expressed that the subcommittee could be helpful with offering further input on the recommendations that were provided. She stressed the importance of the subcommittee focusing on the governance structure of the system, creating a timeline with specific activities, personnel, etc. and measuring success with benchmarks and milestones.
