	The "Ages 6 to 12" tab provides summary counts and percentages of children, ages 6 to 12, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run
	date.
	The "Ages 13 to 17" tab provides summary counts and percentages of children, ages 13 to 17, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run
	date.
	Placement Setting Descriptions: A relative/non-relative placement includes children placed with relatives or approved family friends. Licensed Substitute Care includes children placed in licensed foster care, group
	homes, and residential treatment facilities. The Other placement setting includes children who are missing (runaway/absconded/abducted), in a hospital, correctional placement, or other placement settings not included
	above. Children who are in the process of changing placements (i.e., a placement had been ended and new one has not yet been entered into FSFN) or whose placement information has otherwsie not yet been entered
