CORE REQUIREMENTS FOR ALL MEASURES

- Outcome measures can only be computed for individuals that fall within a valid target population and meet the requirements for a particular measure.
- Output measures can include individuals that fall within a valid target population but are not included in outcome measures because the individual does not meet the requirements for a particular measure.
- Service data must be tied to a valid mental health or substance abuse admission record.
- Reporting will be routinely done at either the ME or State levels, or both.
- Community based performance metrics are not calculated on persons residing in institutional care.
- For individuals with co-occurring mental health and substance use disorders, service records for both mental health and substance abuse are required under an associated mental health and substance abuse episode, or a co-occurring episode.
- All measures will be based on the most recent record that is not an admission and may include comparison with the conditions at the time of admission. Performance will never be measured solely on the basis of the admission record alone.
- Clients may meet criteria for more than one target group but will be placed in the highest acuity group for the purpose of evaluating outcomes.

POPULATIONS

- Major diagnoses groups have been identified for each priority population.
- For both SUBSTANCE ABUSE and MENTAL HEALTH, the most recent **ADMISSION** record is used to determine the population.
