

Summary of Enhancements 1.3.0 (Q1 2019-2020)

1. FASAMS Submission Performance Report (10521)

- Create a new report named “FASAMS Submission Performance Report” for users with the View Job Submission Performance Reports permission. The report will include two charts for completed jobs and created jobs. The report will not be intended to be exported for printing due to the overall width required to accommodate all columns. The report will contain the following columns:
 - Submitting Entity Name
 - Submitter Username
 - File Name / Job Name
 - Data Set Type
 - Processing Status
 - Processing Time (in minutes)
 - Processing Wait Time (in minutes)
 - Created timestamp
 - Processing Start Time
 - Processing End Time
 - Error Free Rate
 - Successful Count
 - Error Count
 - Warning Count

2. Update MCI Interface file generation process (10562)

- Modify the MCI file generation process to do the following
 - replace special characters in the middle initial position with a ‘ ’ blank space
 - remove any ‘.’ periods from the first and last name

3. Update 270_271 interface to convert Unicodes (10638)

- Modify the 270-file generation process to do the following
 - Transform all Unicode characters coming from the Client Module into their alpha character counterpart, if a counterpart exists, when the 270 Medicaid request file is generated
 - If a Unicode does not have an alpha character counterpart, the system should remove the Unicode character completely during 270-file generation

4. Update Encounter interface to remove leading 0s (10639)

- Modify the Client table Medicaid PINs to do the following:
 - Add leading 0s to all 8- and 9-character Medicaid PINs so each PIN has a total of 10 characters
 - Note: All Medicaid PINs in the Client table should have 10 characters after this migration

5. Add Ability to Track Referrals (8347)

- Add the following fields to Treatment Episode Immediate Discharge entity:
 - **ProviderReferredTo** –

- Identifies the Provider, if any, to which the client was referred
- **ReferredToTreatmentSettingCode** –
 - Identifies the Treatment Setting , if any, to which the client was referred
 - Must be a Treatment Setting in FASAMS
- **ReferredToCoveredServiceCode** –
 - Identifies the Covered Service, if any, to which the client was referred
 - Must be a valid CoveredServiceCode value. Valid values are listed in the Covered Service or Project section in Appendix 1 Data Code Values of Pamphlet 155-2
- **ReferredToProjectCode** –
 - Identifies the Project, if any, to which the client was referred
 - Must be a valid ProjectCode value. Valid values are listed in the Covered Service or Project section in Appendix 1 Data Code Values of Pamphlet 155-2

6. Modify Acute Care License Validation from PLADS

- Update license types stored from PLADS interface
 - FASAMS should only store the following license types coming from the PLADS interface
 - Regular
 - Interim
 - Probationary
 - Probationary 2nd
- Remove license types from FASAMS database
 - Delete the licensing records with the following license types:
 - Denied
 - Expired
 - Revoked
 - Surrendered
 - Suspended
 - Waiting Approval
 - Waiting Inspection
 - Waiting Submission

7. Create Enable and Disable User Account Permissions (8852)

- Create 'Disable User Accounts' permission
 - Allow users with this permission the ability to disable user accounts
- Create 'Enable User Accounts' permission
 - Allow users with this permission the ability to enable user accounts
- Add Enable/Disable buttons in the UI
- Add Enable/Disable button to User tile on Administration tab
- Add Enable/Disable button to User Workspace screen
