### STATUS SUMMARY

FFPSA impacts a wide range of child welfare programs, including preventive services, foster care and adoption. The ACT includes significant amendments to Title IV-E (foster care, adoption assistance and Chafee independent living services), Title -B (child welfare services). There are multiple effective dates in the Act. The Department’s approach to implementation is four phased which are listed in the project overview below. This monthly progress report will summarize the actions needed/assigned, and those completed in partnership during the month that move toward compliance with implementation of the FFPSA.
